IEQ-GA - Presidential Column (July, 2020)

There is so much that has occurred since my last Presidential Column in May, 2020. The good news is that COVID-19 virus appears to be receding in certain parts of the world. However, it is continuing to be a major outbreak of illness in other parts of the world. As of the writing of this column (July 21st), there is reported to be over 14.7 million of cases worldwide, and over 600,000 deaths. Nearly every country in the world has had cases of the virus since January, 2020.

IEQ-GA's organizational members and their professional members have been closely involved in the efforts to control the virus. In the past month, a letter signed by over 200 scientists and researchers (many of which are members of the organizations that comprise IEQ-GA) was issued to the World Health Organization (WHO) about the airborne transmission of the virus. The letter was co-authored by Professors Lidia Morawska and Donald Milton, and it discusses the potential for airborne transmission of the COVID-19 virus. As noted in the May Presidential Column, IEQ-GA issued a Position Document on this matter. In response to the letter, WHO is reconsidering its position on airborne transmission of the virus. It is expected that a revised WHO position on this matter will be issued in the next few weeks.

The IEQ-GA Task Force on COVID-19 remains active, and its members are meeting soon to discuss the ongoing pandemic and our response.
